Kalasalingam Academy of Research and Education (KARE) Policy on Minimisation of plastic use

Policy Framed: 19-01-2022

Preamble

Kalasalingam Academy of research and Education (KARE) is committed to promoting environmental sustainability by minimizing the harmful impact of plastic waste on our campus. In alignment with the Indian Government's regulations on the ban of single-use plastics, we aim to make the campus a plastic-free zone, while encouraging recycling and the use of reusable alternatives.

Scope

This policy applies to all members of the KARE community, including students, faculty, staff, and visitors. It covers all areas of the campus, including academic buildings, administrative offices, residential facilities, and outdoor spaces.

Policy Statement

KARE committed to fostering a sustainable environment. To achieve this, the university will implement a ban on single-use plastics on campus. In accordance with the Plastic Waste Management (Amendment) Rules, 2021 issued by the Government of India, the following single-use plastic items are banned across KARE.

- Plastic bags below 75 microns (starting January 2023) and below 120 microns (effective December 2023).
- Single-use plastics: Plastic bags, bottles, straws, cutlery, plates, and cups.
- Styrofoam products: Boxes, plates, and cups.
- Plastic wrappers and packaging: For food items and other products.

Encouraged Practices: Reusability

KARE promotes the use of reusable and eco-friendly alternatives to plastic:

- Cloth, jute, or other biodegradable bags for carrying items.
- Reusable metal, bamboo, or wooden cutlery and straws.
- Steel, glass, or ceramic containers for food storage and beverages.

• Use of refillable bottles and mugs for drinks instead of plastic bottles and cups. Students, staff, and vendors are encouraged to opt for reusable options whenever possible.

Minimization of Plastic Use policy

While our primary goal is to eliminate the use of plastic, we understand that certain types of plastic may still be in circulation. Therefore, KARE is committed to the responsible recycling of plastic waste.

Segregation at Source

- All members of the university community are required to segregate waste at the source. Separate bins will be provided across the campus for the segregation of plastic waste from other waste.
- Recycling Stations: The University will partner with authorized recycling agencies to collect, process, and recycle plastic waste.

Implementation

- Awareness campaigns: The University will conduct regular awareness campaigns to
 educate the campus community about the impacts of plastic pollution and the
 importance of sustainable practices.
- Waste management: Proper waste management systems will be implemented to ensure that plastic waste is collected and disposed of responsibly.

Informational signage is placed around campus to remind individuals about the plastic ban.

Enforcement

- Designated university personnel will monitor compliance with the minimisation plastic ban.
- Violations of the policy will result in strict actions.

Policy Review and Compliance

This plastic use minimisation policy will be reviewed periodically to ensure its effectiveness and to incorporate any necessary updates or improvements. Revisions will be made whenever needed to adapt to new Pollution Control Board and State and Central Government rules, technological advances and institutional needs.

Conclusion

Through the implementation of this minimization of plastic use Policy, KARE aims to lead by example in promoting sustainability and environmental responsibility. Together, we can make a significant impact on our campus and beyond.
