##### Statutory Bodies

A statutory body is an organization that is established by an act of law or statute passed by a legislative body (e.g., Parliament or Congress). These bodies have legal authority to operate, and their functions, powers, and responsibilities are outlined and regulated by the relevant legislation.

##### Non-Statutory Bodies

A non-statutory body is not established by any law or statute. These bodies are usually formed for a specific purpose, often through executive orders or decisions of government departments or ministries. They do not have the legal backing that statutory bodies do, but they can still be important in terms of advisory, regulatory, or operational functions.
