KARE/Policies/ Policy for Women Applications and entry/02 24.01.23

Policy Statement

- 1. KARE admission department is responsible for maintaining records of female applicants. Equal preference is given to eligible and suitable female students for admission under Undergraduate, Post Graduate and Ph.D.
- 2. In the admission process for student applicants, there is no discrimination, and female applicants are treated without bias.
- 3. KARE ensure that financial aid and scholarship opportunities are accessible to students from all backgrounds and also committed to maintaining a supportive environment for individuals who report discrimination or prohibited conduct.
- 4. Financial aid and scholarships will be administered without discrimination, and decisions will be based solely on the applicant's financial need and merit. KARE provides 100 % University scholarship for the Undergraduate students who belong to Economically Weaker Section and first graduate of her family. KARE also provides Fee admission under Women sports quota based on the recommendation from Sports committee of KARE.
- 5. KARE offers a monthly stipend to all postgraduate students who have achieved at least 60% in their undergraduate degree. However, there is a relaxation for female and differently-abled students, who are eligible with a minimum of 50% in their undergraduate degree.
- 6. Female Ph.D. scholars and persons with disabilities (having more than 40% disability) may be allowed an additional relaxation of two (2) years; however, the total period for completion of a Ph.D. programme in such cases should not exceed ten (10) years from the date of admission in the Ph.D. programme.
- 7. Female Ph.D. scholars may be provided maternity leave/child care leave for up to 240 days in the entire duration of the Ph.D. programme.
